Types of Educational Loans

*Federal **Student** Loans – **Student** is borrower*

- Subsidized and Unsubsidized
- Maximum loan limit each year
- Enter repayment 6 months after graduation
- Must complete an MPN and loan counseling the first year you borrow

*Federal **Parent (PLUS)** Loan – **Parent** is borrower*

- Abbreviated credit check required
- Complete application & MPN on FAFSA website
- No annual limit

Billing
Charges

Account...

- It's the Student's account
- Parents/guardians need permission to access and pay
- Authorized User
- Access at my.millikin.edu

Billing...

Charges/Statements by Term:

- August for the Fall term
- January for the Spring term
- Pay in full OR Pay in 4 monthly installments

Email sent each month – statements viewable online via myMillikin

Transactions between statements available online as well. Check myMillikin account regularly.

Charges...

- Full-time Tuition = 12 to 18 credit hours
- Fees: \$22/hour Comprehensive Fee, Welcome Week, Course-Related Fees, Book Fee \$23 per credit hour
- Room Charges: Residence Hall Fee
- Meal Plans
- Other Charges: Postage, Parking
- Fines, ID Charge, etc.
