

**WAIVER AND RELEASE FOR DRIVERS
(STUDENT ORGANIZATION TRAVEL)**

I, _____, hereby acknowledge and I have voluntarily applied to participate in the following Student Organization Travel event: _____ (hereinafter referred to as the "event".) I understand the nature of the event, and I wish to participate in it.

In consideration of permitting me to participate in the event offered by Millikin University, I hereby agree to the following terms and conditions for my participation:

1. I am an adult at least 18 years of age or, if not, that I have secured below the signature of my parent or guardian as well as my own.
2. I wish to participate in the described event, and I accept and assume the risks relating to the event.
3. **I acknowledge that a vehicle under my possession and control will be used to transport me and others for the event. Therefore, I represent, promise, and warrant that:**
 - a. **I have a valid driver's license**
 - b. **I have valid vehicle liability insurance as required by Illinois law.**
 - c. **My vehicle is in good operating condition, including but not limited to good brakes, tires, lights and mirrors**
 - d. **I have never received a citation for reckless driving or driving under the influence of alcohol or drugs, and my driving privileges have never been suspended or revoked.**
 - e. **I have a good driving record.**
 - f. **I will be the only driver of my vehicle during the course of the event (unless there is a genuine emergency).**
4. I understand the possible risks and dangers relating to the described event, including risk of personal loss, personal injury, or even death. No promises or guarantees have been made to me in this regard by Millikin University or others who may be associated with the event.
5. I agree to indemnify and hold harmless Millikin University (and its trustees, employees, officers, and agents) from any injury arising from my participation in the described event, whether the injury is caused by Millikin University's own negligence or otherwise.
6. In consideration of participation in the event, I hereby release, remise and forever discharge Millikin University (and its trustees, employees, officers, and agents) of and from all liability, claims actions and possible causes of action whatsoever that may accrue to me or to my heirs from every loss, damage and injury, including death, that may be sustained by my person and property arising out of or connected with my participation in the described event.
7. I acknowledge that to the best of my knowledge I am physically able to participate in the event, without any undue or unusual risk to myself or to others.

8. This Waiver and Release shall be governed by Illinois substantive law and any litigation related to the enforceability of this document will be brought in the State of Illinois, County of Macon.
9. The terms of this document are binding on the one signing the document, members of his or her family, and his or her spouse, heirs, assigns and personal representatives.
